

Key Information Document –

limited-risk spread bet on an FX pair

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

A spread bet is a leveraged financial derivative entered into with IG on a bilateral basis. It allows an investor to speculate on rising or falling prices in an underlying FX pair.

An investor has the choice to buy (or 'go 'long" on) the spread bet to benefit from the "base" currency of an FX pair rising in relation to the "variable" or "quote" currency; or to sell (or "short") the spread bet to benefit from the price of the variable currency rising in relation to the base currency.

If an investor is long a EUR/GBP spread bet and the price of the underlying FX pair rises, the value of the spread bet will increase. At the end of the bet, IG will pay the difference between the closing value of the bet and the opening value of the bet. If an investor is long and the price of the underlying FX pair falls, the value of the spread bet will decrease. At the end of the bet, the investor will pay IG the difference between the closing value of the bet and the bet and the opening value of the bet.

The price of the spread bet is derived from prices sourced from major liquidity providers to the OTC FX and bullion market.

The leverage embedded within all spread bets has the effect of magnifying both profits and losses. All limited-risk spread bets require a guaranteed stop loss. This enables an investor to put an absolute limit on their maximum loss per trade. If the market price moves through the investor's stop level, the trade is then closed at the requested price – with no risk of slippage even if the market gaps. A premium is charged if the stop loss is triggered, however if the investor closes the position before the stop-loss is activated then no fee will be applied.

Objectives

The objective of the spread bet is to allow an investor to gain leveraged exposure to the movement in the value of the underlying FX pair (whether up or down), without needing to buy or sell the underlying FX pair.

The exposure is leveraged since the spread bet only requires a small proportion of the notional value of the bet to be put down as initial margin.

For limited-risk positions, the margin required will be the larger figure of the two calculations below:

- 1. (Bet size x stop distance) + (limited risk premium x bet size)
- 2. Bet size x price x margin rate

As an example, if an investor buys a spread bet at a size of £10 per point, with an initial margin of 3.33% and EUR/GBP is priced at 8495.0/8496.0. A guaranteed stop is placed 45 points away and there is a two-point limited risk premium.

The margin would be calculated as follows:

Calculation 1: $(\pounds 10 \times 45) + (2 \times \pounds 10) = \pounds 470$ margin Calculation 2: $\pounds 10 \times 8496 \times 3.33\% = \pounds 2,829.17$ margin Therefore, the margin requirement is $\pounds 2,829.17$ (the larger figure of the two).

The margin rate for a limited-risk spread bet is the same as the margin rate for a non-limited-risk spread bet, in this case 3.33% of the total exposure. The total exposure or 'notional value' of the bet is £84,960 (8490 x £10). This shows the effect of leverage, in this case 33.3:1(1/3.33%).

For every point the underlying FX pair moves, the value of the spread bet will change by £10. For instance, if the investor is long and the market increases in value, a £10 profit will be made for every one-point increase in the

market. However, if the market decreases in value, a £10 loss will be incurred for each point the market decreases. Conversely, if an investor holds a short position, a profit is made in line with any decreases and a loss for any increases in the market.

Additional funds may need to be deposited in the case of negative price movement. Failure to do so may result in the spread bet being auto-closed.

Spot and Forward spread bets have a pre-defined maturity date but can be exited prior to this date. In the case of forward spread bets, transactions will be automatically rolled over into the next period – ie, from a March expiry into a June expiry, unless you opt out. There is no recommended holding period, and it is down to the discretion of each individual investor to determine the most appropriate holding period based on their own individual trading strategy and objectives.

IG also retains the ability to terminate any spread bet where it deems that the terms of the bet have been breached.

Intended retail investor

Spread bets are intended for investors who have knowledge of, or experience with, leveraged products. Likely investors will understand how the prices of spread bets are derived, the key concepts of margin and leverage, and that losses may exceed deposits in a given position. They will understand the risk/reward profile of the product compared to traditional share dealing, and desire short-term, high-risk exposure to an underlying asset. Investors will also have appropriate financial means, hold other investment types and have the ability to bear losses in excess of the initial amount invested in a given position.

What are the risks and what could I get in return? Risk indicator



The risk indicator assumes that you may not be able to buy or sell your spread bet at the price you wanted to due to volatility of the market or you may have to buy or sell your spread bet at a price that significantly impacts how much you get back. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance of the product at a very high level.

Spread bets are leveraged products that, due to underlying market movement, can generate losses rapidly.

Guaranteed stops enable investors to put an absolute limit on their potential loss for each trade. Please note that without this protection, losses can exceed the amount invested in a given position. There is no capital protection against market risk, credit risk or liquidity risk. **It may be possible to lose the total balance on your account.**

Be aware of currency risk. It is possible to buy or sell spread bets in a currency which is different to the base currency of your account. The final return you may get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Market conditions may mean that your spread bet trade is closed at less favourable price, which could significantly impact how much you get back. We may close your open spread bet if you do not maintain the minimum margin that is required, if you are in debt to the company, or if you contravene market regulations. This process may be automated.

This product does not include any protection from future market performance, so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see 'what happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

The scenarios shown illustrate how your investment could perform, but are not an exact indicator. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies. What you get will vary depending on how the market performs and how long you hold the spread bet. The stress scenario shows what you might get back in extreme market circumstances, and it does not take into account the situation where we are not able to pay you.

What are the costs?

Trading a spread bet on an underlying FX pair incurs the following costs:

One of	One-off	Spread	The difference between the buy price and the sell price is called the spread. This cost is realised each time you open and close a trade.
Spot and forward		Currency conversion	Any cash, realised profit and losses, adjustments, fees and charges that are denominated in a currency other than the base currency of your account, will be converted to the base currency of your account. A currency conversion fee will be charged to your account as a result.
	Incidental costs	Distributor fee	We may from time to time, after informing you, share a proportion of our spread, commissions and other account fees with other persons, including a distributor that may have introduced you.

How long should I hold it and can I take money out early?

Spread bets are intended for short-term trading, in some cases intraday, and are generally not suitable for long-term investments. There is no recommended holding period, no cancellation period and therefore no cancellation fees. You can open and close a spread bet on an FX pair at any time during market hours.
